Pricing, Booking and Reservation

- a. All displayed pricing is GST inclusive unless otherwise specified by Tiny Creatures & Co.
- b. Bookings are accepted on a first-come, first-served basis.
- c. A non-refundable deposit of \$200 is required to secure a booking.
- d. Tiny Creatures & Co will confirm all bookings upon receipt of a signed booking form and a cleared booking deposit.
- e. Full payment is due 14 days prior to the event date.

Cancellation and Refund Policy

- f. Cancellations must be made in writing 30 days before the event for a partial refund.
- g. No refund will be provided for cancellations made within 10 days of the event.
- h. Tiny Creatures & Co reserves the right to cancel a booking at any time for reasons including but not limited to unforeseen circumstances or non-compliance with these terms.

Use of the Event Space

- i. The hirer is responsible for the event space during the agreed-upon rental period.

- j. Excess and oversized rubbish and belongings must be removed by the hirer at the end of the rental period. Commercial cleaning is included in the booking cost. Additional fees may be incurred if additional cleaning or rubbish removal is required.
- k. Any damage to the premises or equipment must be reported immediately, and the hirer is liable for repair or replacement costs.
- l. Failure to depart the venue by the end of the booking period will incur an overtime fee of \$150 per hour.

Licenses and Permits

- m. The hirer is responsible for obtaining any necessary licenses or permits for the event, including but not limited to alcohol licenses or music permits.
- n. Tiny Creatures & Co may require proof of necessary licenses before the event.
